2. Do not ship horses until you have been notified of stall allotment.
3. Preference will be given to horses that have started this year.
4. Final determination for eligibility to be made by Racing Secretary.
5. Stall applications not signed on the front & back will not receive consideration.
6. Applicant/trainer agrees to vacate and completely clean the stalls allotted to him/her and remove horses, equipment, and other personnel from the premises of State Fair Race Meet within 24 hours after the last race day of the meet

The statutes of the State of Montana, rules and regulations of the Montana Board of Horse Racing, and the horsemen's association recognized by the Great Falls Turf Club (collectively "Rules") shall apply to the race meet to be conducted at the State Fair Race Meet, and Applicant agrees to be bound by them. In consideration of stalls allotted by Great Falls Turf Club to the Applicant, the Applicant accepts the conditions and policies of racing established by Great Falls Turf Club.</li> <li>2. Great Falls Turf Club reserves the right to cancel or amend any race.</li> <li>3. A registration certificate, relating to a horse, must be on file with the Racing Secretary before the entry of the horse is accepted, stakes races excluded.</li> <li>4. Applicant shall be liable for its own acts and omissions, as well as those of its officers, agents, independent contractors, representatives and employees (together, "Representatives"). Applicant agrees to require its Representatives to strictly comply with the Rules. Applicant further agrees that it has sole responsibility for the safety and well being of its Representatives.</li> <li>5. Great Falls Turf Club reserves all rights to photographs, videos tapes, television and motion pictures filmed or produced for non-income or noncommercial use. All entries will be accepted on the condition that if requested by Great Falls Turf Club, the owner, trainer, groom, jockey and all other persons associated with the Applicant who may come into camera range, will sign a formal release permitting the taking of photographs, video tape, filming of such television or motion pictures, and the subsequent exhibition thereof.</li> <li>6. In consideration of the allotment of stalls by Great Falls Turf Club, water and electricity in stables and facilities located on the premises of State Fair Race Meet, the Applicant agrees to enter his/her horses when they are fit to run and suitable races are programmed. Applicant's horses will not be withheld as entries for any reason other than illness or inability to run for other valid causes.<br/> <b>Applicant agrees to vacate and completely clean the stalls allotted to him/her and to remove horses, equipment and other personnel from the premises of State Fair Race Meet within twenty-four (24) hours after the last race day of the meet.</b></li> <li>7. The Applicant and all personnel under his/her control will refrain from smoking or using alcoholic beverages in the barn area. Possession of alcohol is prohibited in the barn area. The Applicant is responsible for the</li> </ol> | <ol style="list-style-type: none"> <li>cleanliness of their assigned areas. The area shall extend from their assigned stalls to the roadway. This overall cleanliness includes, but is not limited to trash, weeds, and other debris. The Applicant is responsible for any damages caused to the assigned area by the Applicant and its Representatives. No alterations may be made to the assigned area without prior approval by Great Falls Turf Club. No cooking is permitted in or around the barns. No pets are permitted on the backstretch and barn area.</li> <li>8. This application, or its acceptance by the Great Falls Turf Club, shall not be construed as a lease of any particular space at State Fair Race Meet, but, upon acceptance of Great Falls Turf Club, merely constitutes a revocable license or permit under the terms and conditions herein set forth. The signature of the Applicant on this Application is an acknowledgement that this applicant agrees to be subject to the terms and conditions hereof.</li> <li>9. Great Falls Turf Club reserves the right to exclude any horse or horseman from participating in the race meet for any reasons, including but not limited to: drug violations, qualifications, participating in programs, poor performance or any conduct not considered beneficial to the overall racing program at the State Fair Race Meet.</li> </ol> |

**WORKERS COMPENSATION**

**WAIVER AND INDEMNITY**

The undersigned, in consideration of the allotment of stalls of Great Falls Turf Club, does hereby waive, release and forever hold harmless Racing Associates of Montana, Ltd., d/b/a Great Falls Turf Club, its officers, agents, representatives, employees, affiliates, and any others acting on behalf of Great Falls Turf Club (hereinafter the "Indemnified Parties"), from any and all liability for any loss, damage or destruction or injury to any person, horse or other personal property owned or leased by the Indemnified Parties, except to the extent the loss, damage, destruction or injury is caused solely by the negligence of any of the indemnified parties. The undersigned agrees to forever indemnify and reimburse the Indemnified Parties for any and all fees, expenses, costs or damages caused by undersigned and its Representatives for any horse, person, property owned, leased or borrowed by the undersigned, while on the premises owned or leased by the Indemnified Parties.
